Master Chief Michael P. Leavitt assumed his duties as the eleventh Master Chief Petty Officer of the United States Coast Guard on May 21, 2010. As the senior enlisted advisor to the Commandant, Master Chief Leavitt advises him on enlisted workforce policies, advocates for military benefits and entitlements, is the senior enlisted mentor, and acts as the sounding board for select enlisted administrative actions. Master Chief Leavitt also devotes much time traveling throughout the Coast Guard observing training and communicating with Coast Guardsmen and their families.


At the time of his selection as the eleventh Master Chief Petty Officer of the Coast Guard, Master Chief Leavitt was the Senior Enlisted Advisor to the Deputy Commandant for Operations at Coast Guard Headquarters in Washington, DC. Previous operational duties include Officer in Charge, Station Cape Disappointment, Ilwaco,



WA; Officer in Charge Station Tillamook Bay, OR; Officer in Charge Station Humboldt Bay, CA; Officer in Charge, Station Hatteras Inlet and Station Ocracoke (Station Small), NC; Officer in Charge, Coast Guard Cutter POINT DORAN, Everett, WA; Officer in Charge, Station Maui, HI; Executive Petty Officer, Coast Guard Cutter KANAWHA, Pine Bluff, AR; Executive Petty Officer, Station Siuslaw River, OR; First Lieutenant, Coast Guard Cutter NAUSHON, Ketchikan, AK; crewmember, Station Umpqua River, OR and Station Coos Bay, OR; and crewmember, Coast Guard Cutter BOUTWELL, Seattle WA.

Master Chief Leavitt's personal awards include the Coast Guard Medal, a Meritorious Service Medal with an operational distinguishing device, five Coast Guard Commendation Medals with an operational distinguishing device, three Coast Guard Achievement Medals with an operational distinguishing device and numerous other individual and unit awards. He has also earned a permanent Cutterman insignia, Surfman insignia, Boat Forces Operations insignia, and both Command Afloat and Ashore devices.

A native of Fruitland, Idaho, Master Chief Leavitt holds a Bachelor of Science Degree in Business Administration and a Master of Arts Degree in Training and Education. He is also a graduate of Chief Petty Officer Academy Class 34.



Welcome to Long Beach

Long Beach is situated in Los Angeles County, on the Pacific coast of the United States. The city is the 36th-largest city in the nation

and the seventh-largest in California. As of 2010, its population was 462,257. Long Beach is located about 20 miles south of downtown Los Angeles and 105 miles north of San Diego.

The city is a dominant maritime center of the United States. It wields substantial influence critical to the global economy. The Port of Long Beach is the United States' second busiest container port and one of the world's largest shipping ports. The city also maintains a large oil industry with the substance being found both underground and offshore. Manufacturing sectors include those in aircraft, car parts, electronic and audiovisual equipment, and home furnishings. It is also home to headquarters for corporations including Epson America, Molina Healthcare, and SCAN Health Plan. Long Beach has grown with the development of high-technology and aerospace industries in the area.

Indigenous peoples have lived in coastal southern California for at least ten thousand years. During the late 18th century, the area was under Spanish rule. During the mid to late 19th century the area was home to a thriving cattle ranch, which in the late 1850's was the largest in the US, and as many as 30,000 sheep. The City of Long Beach was officially incorporated in 1897.

The town grew as a seaside resort with light agricultural uses. The Pike was the most famous beachside amusement zone on the West Coast from 1902 until 1969, it offered bathers food, games and rides, such as the Dual Ferris Wheel and Cyclone Racer' roller coaster. Gradually the oil industry, Navy shipyard and facilities and port became the mainstays of the city. The discovery of the Long Beach Oil Field, brought in by the gusher at the Alamitos No. 1 well, made Long Beach a major oil producer; in the 1920s the field was the most productive in the world. In 1932, the even larger Wilmington Oil Field, fourth-largest in the United States, was developed, contributing to the city's fame in the 1930s as an oil town.

The city was the site of "The Los Angeles Air Raid of 1942" during World War II, when observers for the Army Air Corps reported shells being fired from the sea. Anti-aircraft batteries fired into the night sky, although no planes were ever sighted.

Before the war, Long Beach had a sizable Japanese-American population, who worked in the fish canneries on Terminal Island and owned small truck (produce) farms in the area. Due to exaggerated fears on the coast and racial prejudice, state officials persuaded the national government to remove Japanese nationals and Japanese Americans for internment in 1942 to inland facilities. Most did not return to the city after their release from the camps. Due to this and other factors, Japanese Americans now make up less than 1% of the population of Long Beach, but the Japanese Community Center and a Japanese Buddhist Church survive. The Japanese-American Cultural Center is located over the Gerald Desmond Bridge and the Vincent Thomas Bridge in San Pedro.



At the time of his selection as the fifth Master Chief Petty Officer of the Coast Guard Reserve Force, Master Chief Allen served as Sector Jacksonville Reserve Command Master Chief in Jacksonville, FL. His previous assignments include Coast Guard Leadership and Professional Development and Coast Guard Reserve Affairs,



Washington, DC; Coast Guard Station St. Inigoes, MD; Coast Guard Station Washington, DC; and Coast Guard Station Alexandria, VA. In addition, Master Chief Allen has been recalled to active duty in response to Coast Guard operations that have ranged in size and scope from the Mariel Boat Lift to the Air Florida Flight 90 crash to the 9/11 terrorist attacks.

A native of Takoma Park, MD, Master Chief Allen holds a Bachelor of Arts Degree in English with a minor in Public Relations from Frostburg State University. He has also completed his coursework toward a Master of Arts degree in Modern Humanities at Frostburg State University.
