Dear President Lorigan,

My name is Sonny Sonnenfeld. I am writing to you on behalf of our sick and wounded veterans. I am sending a copy of this letter to each group chairperson of the military coalition. I was a staff sergeant combat infantryman in World War II. I participated in one airlift and five "H" hour landings in New Guinea and the Philippines. I was awarded a Silver Star Medal. Fortunately, I came home whole.

It is a well-documented fact that our government is not providing timely or adequate medical care to our sick and wounded veterans. As a matter of fact, it takes longer to get proper care for our veterans today than it did four years ago. After World War II we had about sixteen million veterans. We had many programs for them - health care, VA hospitals, the GI bill of rights, 52-20 unemployment insurance, mortgage help, etc. - and we managed to take care of them in a timely fashion.

70% of the veteran's claims have been pending for over 125 days (the V.A.'s benchmark for timely action). The wait is just for evaluation not for care. Care can take another six or more months. The V.A. and the President think that nine months is timely care. It is not. I believe that the American people do not think that nine months is timely care. Consider that our soldiers are sent into combat with about six months of combat training.

This is an outrageous and un-American situation. The American people

can and want "To Do The Right Thing" for our sick and wounded veterans. The problem is that Washington pays lip service to the problem. The president and the Congress refuse to fund timely and proper care for our veterans so the situation continues to get worse. It is really about money. The President and congress are unwilling to do their proper job.

There is a way to have our nation "Do The Right Thing". Send a copy of this letter or a similar letter to everyone of your members. Ask your members to send a copy of this letter to President Obama, Vice President Biden, and every member of congress from their state. Ask your members to send copies to every newspaper, radio and TV station in their area. Ask your members to ask their friends and relatives to also send letters to everyone mentioned above.

Ask every TV and radio station in the member's area to include a sick or wounded veteran in every news program. Have the vet tell his/her story - what he/she did in the service - how he/she got sick or wounded, and their experience in trying to get help from the V.A.

We can and must embarrass the President and congress to "Do The Right Thing". The following is how it can happen.

#### The President should:

Call a meeting of all the players involved - the Vice President, the Cabinet, the leaders of both parties of Congress, the top officers in the Armed Services, the budget director, the leaders of the Dept. of Veteran Affairs, the Surgeon General and whomever else is needed. Once they are all seated (lock the door) for effect and say something like the following:

"Ladies and Gentlemen: I called you into this office today to implement one of the most important matters of my presidency and your tenure. It is about our sick and wounded veterans and the care that we are – and are not – providing to them. We have asked these men and women, young and old, to go into combat to protect our nation. They are now coming home. Many are sick and many are wounded. We say that it is our solemn obligation to provide to them the best medical care in the world, but they are not getting it. These women and men have to wait over 125 days just to be evaluated - not to get medical help, but just to be evaluated. That is unacceptable.

In the beginning of 1941, before World War II started President Roosevelt knew that the nation would need ships to send arms and supplies to Britain, Australia and Russia. He called on Henry Kaiser who took a bare strip of land on Terminal island in San Pedro, CA - land with no factory, no machinery, no trained labor force - and in less than 90 days Henry Kaiser was launching one Liberty Ship a day.

Here is what I am demanding of you. After this meeting you all will meet with the Vice President in the War Room because, Ladies and Gentlemen, I am declaring war for our Vets. The Vice President is my point man and General Patraeus will be commanding the program. I am going to appoint a new leader for the veteran's administration. I will ask the senate to approve General Powell as the new secretary.

What I want from you is a complete plan that will enable all Veterans to get full medical evaluation and care within 5 days of requesting it.

I want the plan to be fully operational within 90 days from today. Do whatever you have to do to make it happen. Draft or otherwise engage doctors, nurses and other medical personnel. Put the best computer people to work for you. Buy hospitals and drug companies if you have to. In other words do everything that you have to do to make it happen. If you need it, I will declare a national emergency to give you all the power that you will need to do it – and you will do it.

Today is the 20th of the month and it is 10:30am. Be back here on the 23rd at 10:30am with a fully operational plan and I want the plan to be FULLY – I MEAN FULLY – operational in 90 days from now – or sooner.

If any of you think that you cannot do this raise your hand AND I will replace you with someone who can do it. If we can take a bare piece of

land and within 90 days launch a Liberty Ship a day we can find a way to take care of our Veterans in a timely fashion.

This is the way that we will fund this proposal. I will ask Congress to pass an obligatory payment within 10 days and that will be due in 30 days. The money will go into a special fund to be used for veterans only. All taxpayers will pay the obligatory payment. The payment will be based on total income not adjusted income.

On income up to \$100,000- one quarter of one percent
On income up to \$250,000- three eighths of one percent
On income up to \$500,000- one half of one percent
On income up to \$1,000,000- three quarters of one percent
On income up to \$10,000,000- one percent
On income over \$10,000,000- one and one half percent

I believe that the vast majority of the people of the United States of America will agree with this plan. The people want to "Do The Right Thing" for our veterans, and are willing to pay for it.

Now get out there and go to work - or get out of the way and let me put someone in your place who will do it. This is a direct order from your Commander-in-Chief."

If the president does the above and the American people make known their feelings to the President and Congress, we can shame Washington into "Doing The Right Thing".

The sick and wounded veterans of America need your help. Please execute this plan. I will appreciate your letting me know what you do.




