# Admiral Robert J. Papp, Jr.

Commandant, U.S. Coast Guard



Admiral Robert J. Papp, Jr. assumed the duties of the 24th Commandant of the U.S. Coast Guard on May 25, 2010. He leads the largest component of the Department of Homeland Security (DHS), comprised of 42,000 active duty, 8,200 Reserve, 8,000 civilian and 31,000 volunteer Auxiliarists.

The Coast Guard is "Semper Paratus" – Always Ready – to use its distinctive blend of military, humanitarian and law enforcement capabilities to save lives and property at sea, protect and maintain our ports and maritime transportation system, secure our borders, respond to natural disasters, protect our marine environment and defend our Nation. The Coast Guard is also America's oldest continuous seagoing service and one of the Nation's five armed services. We trace our history back to August 4th, 1790, when the first Congress authorized the construction of ten vessels to enforce tariff and trade laws and to prevent smuggling. Our people are committed to the Coast Guard's core values of Honor, Respect and Devotion to Duty.



As a flag officer, Admiral Papp served as Commander, Coast Guard Atlantic Area, where he was operational commander for all U.S. Coast Guard missions within the eastern half of the world and provided support to the Department of Defense; as the Chief of Staff of the Coast Guard and Commanding Officer of Coast Guard Headquarters; as Commander, Ninth Coast Guard District, with responsibilities for Coast Guard missions on the Great Lakes and Northern Border; and as Director of Reserve and Training where he was responsible for managing and supporting 13,000 Coast Guard Ready Reservists and all Coast Guard Training Centers.

Admiral Papp has served in six Coast Guard Cutters, commanding four of them: RED BEECH, PAPA, FORWARD, and the training barque EAGLE. He also served as commander of a task unit during Operation ABLE MANNER off the coast of Haiti in 1994, enforcing United Nations Sanctions. Additionally, his task unit augmented U.S. Naval Forces during Operation UPHOLD DEMOCRACY.

He is a 1975 graduate of the United States Coast Guard Academy. Additionally, he holds a Master of Arts in National Security and Strategic Studies from the United States Naval War College and a Master of Science in Management from Salve Regina College.

Admiral Papp is the 13th Gold Ancient Mariner of the Coast Guard. The Gold Ancient Mariner is an honorary position held by an officer with over ten years of cumulative sea duty who has held the qualification as a Cutterman longer than any other officer.

Admiral Papp is a native of Norwich, Conn. He is married to the former Linda Kapral of East Lyme, Conn. Admiral and Mrs. Papp have three daughters, and one granddaughter.



## *Welcome to Daytona Beach*

Daytona Beach was founded in 1870 and officially became a city when it was incorporated in 1876. Most sources agree that it received its name from its founder Matthias D. Day, a business tycoon from Mansfield, Ohio. He purchased 3,200 acres in the fall of 1870 for the sum of \$1,200. In 1926, the three separate towns of Daytona, Daytona Beach and Seabreeze merged as "Daytona Beach."

Made famous for its wide beach and smooth, hard-packed sands, Daytona Beach became widely known in the early 1900s for high-speed automobile testing, and later, racing. This made the beach a mecca for racing enthusiasts. By the 1920s, it was dubbed the "World's Most Famous Beach." As more and more racing took place, the sandy beaches gave way to the development of the famous racetrack known as the Daytona International Speedway, which was built by NASCAR founder William "Bill" France. The speedway has been hosting the Daytona 500 since 1959 and attracts thousands of tourists and race enthusiasts from all over the world in search of thrills.

Today the hard-packed beach sand and the alluring Atlantic Ocean attract millions of tourists annually. The Daytona Beach area boasts one of only a few beaches where driving and parking is allowed. It's also perfect for building sand castles, bike riding, jogging, fishing, swimming, surfing or just relaxing in the warm sunshine.

The city is also attractive to college students searching for their perfect education. There are five institutions of higher learning in the city -- Bethune-Cookman University, Daytona State College, Embry-Riddle Aeronautical University, Keiser College and a University of Central Florida satellite campus.

Although the city is largely known for the speedway and its beach, today it offers a wide variety of famous landmarks and cultural centers. Such landmarks include Jackie Robinson Ballpark, Halifax Harbor Marina, Tarragona Arch, Municipal Stadium, Bethune-Cookman University, Ocean Center, Peabody Auditorium, the Clock Tower and Bandshell, Museum of Arts and Sciences and the Daytona Beach Pier.





## Rear Admiral William D. Baumgartner

Commander  
Seventh Coast Guard District  
Miami, Florida



Rear Admiral Baumgartner serves as Commander of the Seventh Coast Guard District headquartered in Miami, Florida. As District Commander, he is responsible for all Coast Guard operations in the Southeast United States and the Caribbean Basin including Florida, Georgia, South Carolina, Puerto Rico, the U.S. Virgin Islands and over 15,000 miles of coastline. In addition, the Seventh District shares operational borders with 34 Foreign Nations and Territories.



Prior to assuming command of the Seventh District, Rear Admiral Baumgartner served as the Judge Advocate General and Chief Counsel of the United States Coast Guard from April 2006 to April 2010. Rear Admiral Baumgartner began his Coast Guard career in surface operations and served as the Commanding Officer of USCGC POINT VERDE and USCGC PENOBSCOT BAY, as a deck officer on USCGC DEPENDABLE, and as an operations center controller for the Eighth Coast Guard District where he directed search and rescue, law enforcement and other Coast Guard operations in the Gulf of Mexico.

Prior to his tenure as Judge Advocate General and Chief Counsel, Rear Admiral Baumgartner served as Chief, Office of Maritime and International Law, at Coast Guard Headquarters and headed the U.S. delegation to the Legal Committee of the International Maritime Organization. From 2002 to 2004, he served as the Staff Judge Advocate for the Seventh Coast Guard District in Miami, FL and as the Chief of Staff for Homeland Security Task Force Southeast, an interagency task force charged with planning for and executing Caribbean mass migration deterrence and response operations. Previous legal assignments include the Eighth Coast Guard District, in New Orleans, LA, Coast Guard Maintenance & Logistics Command Pacific in Alameda, CA, and Naval Legal Service Office West in San Francisco, CA. He also served as the Chief, Inventory Management Branch at Coast Guard Supply Center Brooklyn.

Rear Admiral Baumgartner is a native of Collinsville, IL and a 1980 graduate of the U.S. Coast Guard Academy where he received Bachelor of Science degrees in Marine Engineering and Electrical Engineering. He holds a Master of Business Administration degree from the University of New Orleans and a Juris Doctor degree, magna cum laude, from Harvard Law School where he also served as an editor on the Harvard Law Review.

# The World's Most Famous Beach



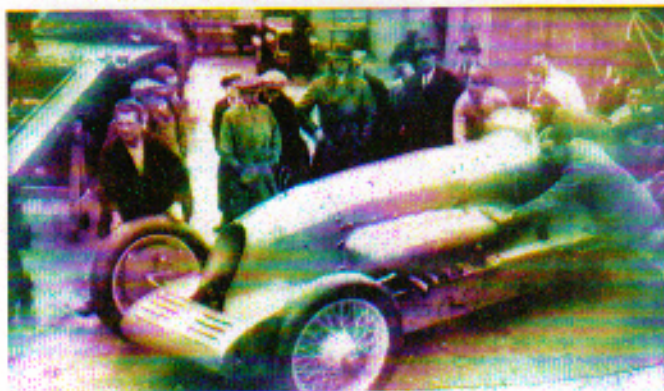
By foot, bike or car, there are plenty of ways to enjoy Daytona Beach's warm sunshine, hard-packed sands and beautiful ocean.

The beach is accessible and free for pedestrians and bicyclists 24 hours a day, depending on tides and weather conditions.

Driving and parking on the beach is open to vehicles from sunrise to sunset from November 1 through April 30 and from 8 a.m. to 7 p.m. from May 1 through October 31.

There is no cost for pedestrians and bicyclists to access the beach.

From February 1 through November 30, there is a \$5 per day per vehicle user fee to drive on the beach.



## The Fastest Beach on Earth

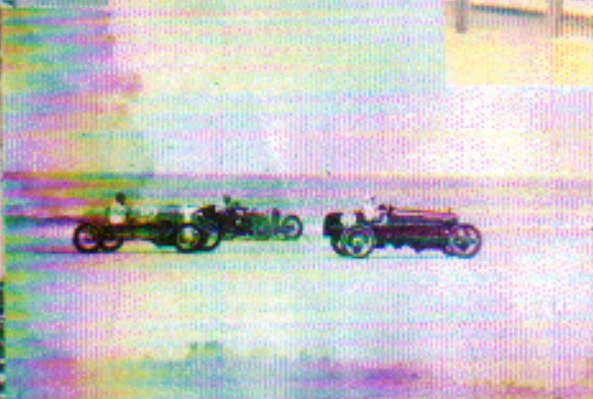
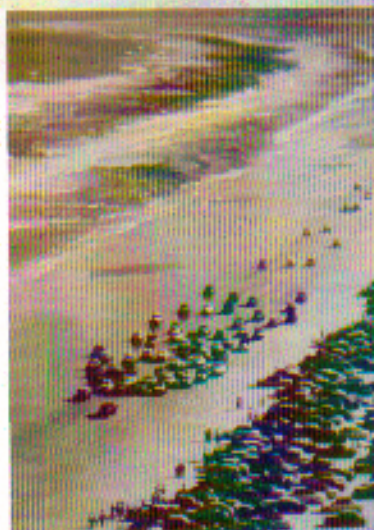
Daytona provided up to 23 miles of straight, gently sloping hard-packed sands over 500 feet wide at low tide. It was also bordered on the shore side by a continuous run of grass-tufted dunes providing ideal vantage points for spectators. 1903 was the first officially organized event with Alexander Winton setting a new beach record for the measured mile of 68.198mph. It was only a year later in 1904, that the first Daytona record appears in the record books. Millionaire William K. Vanderbilt in his Mercedes took the record away from Henry Ford with a 39 second measured mile at 92.30mph. The last ultimate land speed record at Daytona was again by Malcolm Campbell in 'Bluebird' on 7th March 1935 at a speed of 276.82mph. The peak speed on one run was 330mph and is the highest speed to be set on the beach. In total 15 land speed records were set on the beach.



# Then came stock cars...

## The Daytona Beach-Road Course

The course started on the pavement of highway A1A. It went south two miles on A1A to the end of the road, where the drivers accessed the beach at the south turn, returned two miles north on the sandy beach surface, and returned to A1A at the north turn. The first stock car race was held in March of 1936 and continued until 1941 when racing was interrupted by World War II. Racing resumed in 1947 and it was obvious to many that the sport of motor racing needed a sanctioning body of its own. In December 1947, "Bill" France, Bill Tuthill and 18 racing men gathered in the Streamline Hotel at 140 South Atlantic Avenue in Daytona Beach to form the **National Association for Stock Car Auto Racing (NASCAR)** with France as its President. The name was coined by legendary Atlanta racing mechanic, Red Vogt, who operated a garage on Bellevue Avenue behind the Daytona Beach Airport. Tuthill was the national secretary and Erwin G. "Cannonball" Baker was Commissioner. The first office was in the Selden Building located at 800 Main Street (now Froggy's Saloon.) By 1957 the end of beach racing was in sight. Construction began on the new superspeedway in the summer of 1958. The first Daytona 500 was run on the new track in 1959.

Adult: \$22

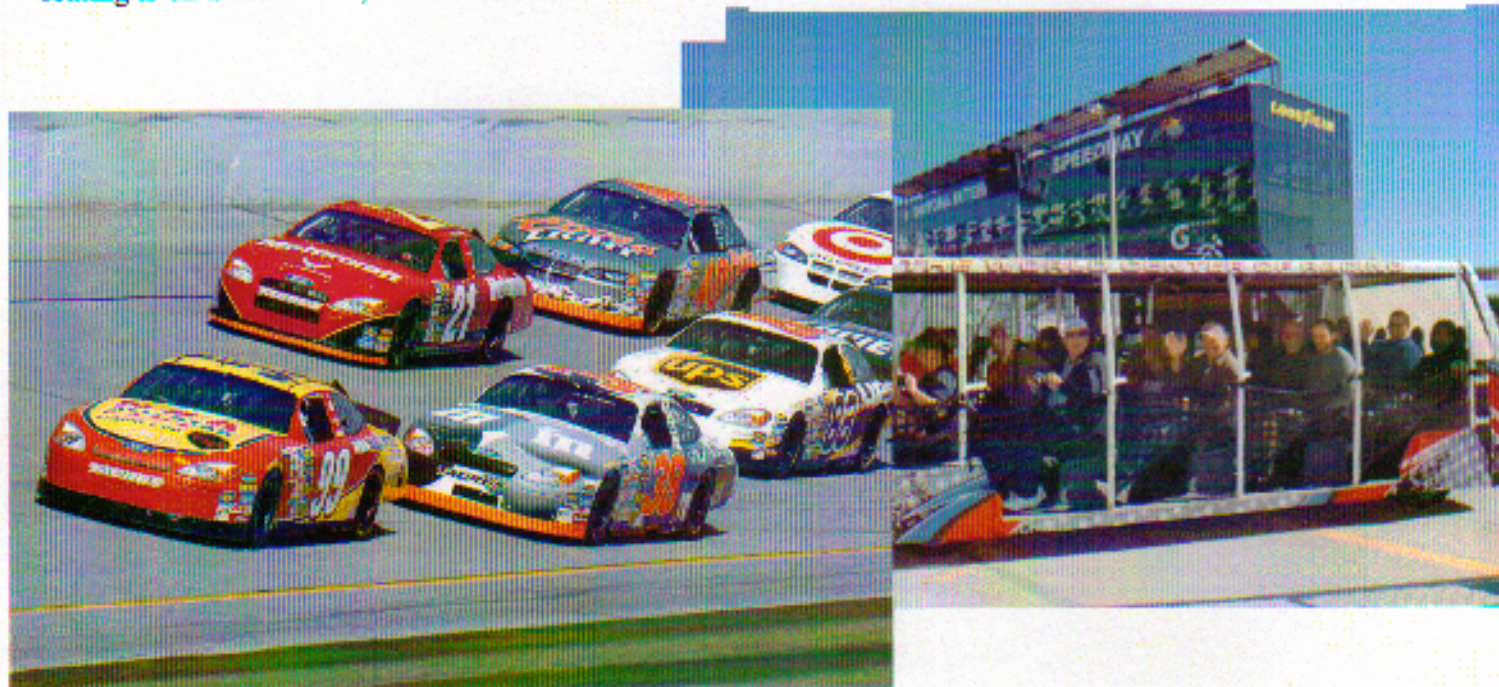
**Hours:** Operates daily from 10:00am-3:00pm every hour on the hour. Each tour capacity is limited and seating is on a first-come, first served basis.
